BUDGET AMENDMENT #02

WHEREAS, subsequent to the adoption of the Fiscal Year 2017-2018 budget for the St. Lucie County Fire District, in order to reduce the number of transfers between unrestricted funds, which are incurred by fiscal year end clean-ups, the budgets of the Health Insurance and Workers Comp Fund and the Reserve for Retirement Fund are being consolidated in the General Fund; and

WHEREAS, Section 189.418(6) (c), Florida Statutes, requires the St. Lucie County Fire District to adopt a resolution to amend the budget.
