



**ST. LUCIE COUNTY FIRE DISTRICT
RESOLUTION NO. 699-20**

**A RESOLUTION OF THE BOARD OF COMMISSIONERS FOR THE
ST. LUCIE COUNTY FIRE DISTRICT OF ST. LUCIE COUNTY,
FLORIDA, ADOPTING THE FINAL BUDGET FOR FISCAL YEAR
2020 – 2021 AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the Board of Commissioners for the St. Lucie County Fire District, of St. Lucie County, Florida has made the following determination:

1. On September 9, 2020, after TRIM notices were mailed to all property owners pursuant to Section 200.069, Florida Statutes, the Board of Commissioners for the St. Lucie County Fire District held a public hearing to consider adopting the tentative budget. Following the public hearing, as required by Florida Statute 200.065, the Board adopted the Fiscal Year 2020-2021 Tentative Budget; and
2. On September 16, 2020, after notice was published in the Tribune on September 12, 2020, the Board held a Public Hearing and Adopted the Final Budget for Fiscal Year 2020-2021; and

WHEREAS, the Board of Commissioners for the St. Lucie County Fire District, of St. Lucie County, Florida, set forth the appropriations and revenue estimate for the Budget for Fiscal Year 2020-2021 in the amount of \$110,527,528.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners for the St. Lucie County Fire District of St. Lucie County, Florida, that:

1. The FY 2020-2021 Final Budget is adopted.
