RESOLUTION NO. 718-21**

**A RESOLUTION OF THE BOARD OF COMMISSIONERS FOR THE
ST. LUCIE COUNTY FIRE DISTRICT OF ST. LUCIE COUNTY,
FLORIDA, ADOPTING THE TENTATIVE BUDGET FOR FISCAL
YEAR 2021 – 2022 AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the Board of Commissioners for the St. Lucie County Fire District, of St. Lucie County, Florida has made the following determination:

On September 8, 2021, after TRIM notices were mailed to all property owners pursuant to Section 200.069, Florida Statutes, the Board of Commissioners for the St Lucie County Fire District held a public hearing to consider adopting the tentative budget. Following the public hearing, as required by Florida Statute 200.065, the Board adopted the Fiscal Year 2021-2022 Tentative Budget; and

WHEREAS, the Board of Commissioners for the St. Lucie County Fire District, of St. Lucie County, Florida, set forth the appropriations and revenue estimate for the Budget for Fiscal Year 2021-2022 in the amount of \$121,514,749.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners for the St. Lucie County Fire District of St. Lucie County, Florida, that:

1. The FY 2021-2022 Tentative Budget is adopted.
