

**ST LUCIE COUNTY FIRE DISTRICT  
RESOLUTION NO. 742-23**

**A RESOLUTION OF THE ST. LUCIE COUNTY FIRE DISTRICT,  
APPOINTING FIRE DISTRICT CLERK TREASURER PATRICIA  
MARSTON-DUVA, AS THE FIRE DISTRICT BOARD'S  
REPRESENTATIVE MEMBER TO THE ST. LUCIE COUNTY FIRE  
DISTRICT GENERAL EMPLOYEES PENSION TRUST FUND BOARD;  
PROVIDING A TERM OF OFFICE; AND PROVIDING AN EFFECTIVE  
DATE.**

**WITNESSETH:**

**WHEREAS**, the Board of Commissioners of the St. Lucie County Fire District (“Fire District Board”) is authorized to designate two representative members to the St. Lucie County Fire District General Employees Pension Trust Fund Board, who shall serve at the pleasure of the Fire District Board, pursuant to the provisions of St. Lucie County Fire District Resolution No. 458-06; and

**WHEREAS**, Marti Newport, Assistant Fire Chief, was appointed for a two-year term pursuant to Resolution 706-20 and Fire District Staff Accountant, Carl Trabulsy, was appointed for a two-year term pursuant to resolution 651-18; and

**WHEREAS**, Patricia Marston-Duva was appointed as the Fire District Board representative to the St. Lucie County Fire District General Employees’ Pension Trust Fund Board, on May 19, 2021, for a two (2) year term of office.

**WHEREAS**, the current term of office for Ms. Marston-Duva is set to expire on May 19, 2023; and

**WHEREAS**, Clerk Treasurer Marston-Duva has obtained the Florida Certified Public Pension Trustee certification and is eminently qualified to perform the functions of the Fire District Board’s representative members to the St. Lucie County Fire District General Employees Pension Trust Fund Board.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the St. Lucie County Fire District, that the following is hereby adopted:

Section 1. The Fire District Board hereby appoints Patricia Marston-Duva, Clerk Treasurer, as its representative member to the St. Lucie County Fire District General Employees Pension Trust Fund Board, pursuant to the provisions of St. Lucie County Fire District Resolution No. 458-06.

Section 2. Clerk Treasurer Marston-Duva shall serve a two (2) year term of office, unless sooner replaced by the Fire District Board at whose pleasure she shall serve.

Section 3. This Resolution shall take effect immediately as provided by law.


